- (i) A colour blind person shall not be eligible for recruitment. If at any stage of service career, a person is found to be colour blind, he will be medically boarded out as per SHAPE policy in vogue in the ITBPF.
- (ii) The candidate must not have knock knee, flat foot, varicose veins or squint in eyes and should possess high colour vision.
- (iii) Must be in good mental and bodily health and free from any physical defect likely to interfere with the efficient performance of duties.

#### (b) Tattoos: -

 Content: Being a secular country, the religious sentiments of our countrymen are to be respected and thus, tattoos depicting religious symbol or figures and the name, as followed in Indian Army are to be permitted.

- iii) <u>Size</u>: Size must be less than ¼ of the particular part (Elbow or Hand) of the body.

#### Note :-

In case, a candidate has undergone removal of tattoo (s) prior to appearing for recruitment process and the same has faded substantially, this will be treated as a "scar" and not a tattoo. Such candidates will be permitted to undergo the entire selection process with the approval of Presiding Officer of the recruitment Board. Further, the scar resulting due to removal of tattoo will be reviewed by the Medical Board of Officer during Detailed Medical Examination.

#### 5. HOW TO APPLY AND BY WHICH DATE:

Candidates are advised to fill the online application form after reading the instructions carefully and should provide genuine and functional e-mail ID and Mobile number at the time of filling online application form. Details as required under various segments should be mentioned clearly, correctly and logically. As the applications need to be submitted online only, applications received offline shall not be considered and will be rejected summarily.
- b) Candidates are to fill all information e.g. Gender/Category (UR/SC/ST/OBC (NCL)/EWS etc), Employment status/Riots affected, etc. in the profile created on ITBP recruitment website before submission of online application. Any false/incorrect information in online application will lead to cancellation of candidature and no request for change in such details will be considered at later stages.

- b) Candidates are required to bring a clear & legible print out of their online application form & admit card; else they will not be permitted to enter the venue of Physical Efficiency Test (PET) & Physical Standard Test (PST).

(iv) If, the female candidate declares that she is pregnant before PET/PST, then a confirmatory pregnancy test to be done and in case she is found to be pregnant, irrespective of duration of pregnancy, she may be declared temporary unfit and her appointment shall be held in abeyance until the confinement is over. However, female candidate who are declared temporary unfit will require to appear and qualify in remaining stages of recruitment i.e. PST, Written Examination, Documentation and Medical Examination. The vacancy against which a women candidate was selected will be kept reserved for her. She will be reexamined for Physical Standard Test (PST)/Physical Efficiency Test (PET) six weeks after the date of confinement, subject to the production of the medical certificate of fitness from a registered medical practitioner. If she is found fit, she may be appointed to the post kept reserved for and allow the benefit of seniority in accordance with the instructions of the Government, as amended from time to time. 

#### Note:-

PET will not be held for Ex-servicemen. However, they require to qualify the requisite PST, Written Examination, Documentation and Medical Examination.

#### PHYSICAL STANDARD TEST (PST)

- (i) Candidates who qualify in PET will be screened for Height, Weight and Chest measurement (Chest measurement for male candidates only). Those who do not meet the required physical measurements, as applicable will be eliminated at that stage and rejection slip shall be issued by the Presiding Officer.
- (ii) Physical Standard of female candidates shall be measured by female staff only. Chest measurement of female candidates should not be taken. Besides, in case of female pregnant candidates shall be dealt as per instructions issued by the Central Government for PET/PST stage.
- (iii) Candidates who fail to qualify PST shall be eliminated from that stage and rejection slip shall be issued by the Presiding Officer.
- (iv) Rejection slip for less in height and chest will be issued at the time of PST. Board shall ensure that measurement is mentioned in writing in the rejection slip. In case, if candidate is not satisfied with the physical measurement recorded by the Board, he/she may make a representation/appeal in writing to the Presiding Officer of the Recruitment Board on the same day for re-measurement. In such case, the physical measurement of aggrieved candidate(s) shall be measured by the Presiding Officer himself and shall dispose off the representation/appeal immediately in writing to the candidate then and there. In case any candidate refuse to sign or leave the PST centre without signing the rejection slip, the recruitment board should endorse the remarks in the rejection slip as "candidate refused to sign/candidate left without receiving rejection slip/candidate did not turn up to receive rejection slip" and same may be kept in record properly after duly signed by the Presiding Officer of the board.
- (v) Underweight/overweight candidates will be allowed to participate for next stage of recruitment and shall not be debarred at PST stage. The final decision on fitness/unfitness due to underweight/overweight will be decided at the time of Detailed Medical Examination (DME) based on the weight and age on the day of DME and the height as measured by the PST Board.
- (vi) The decision of the Presiding Officer will be final and no further appeal or representation in this regard will be entertained



thereafter. There is no provision of appeal for Physical Efficiency Test (PET).

Note:- PET will not be held for Ex-servicemen. However, Ex-servicemen will be required to qualify the requisite PST, Written Examination, Documentation and Medical Examination.

#### PHASE - II

#### Written Examination (200 marks)

- (i) The candidates who qualify in Physical Standard Test (PST) will be required to undergo written examination. Admit cards to the candidates, will be issued online by mentioning date and venue of the written Examination. Candidates have to download online admit card from ITBPF recruitment website i.e. www.recruitment.itbpolice.nic.in.
- (ii) The written examination carrying 200 marks. However, pattern of written test i.e. OMR based or Computer Based Test (CBT) will be at the discretion of ITBPF. The pattern of question paper of written examination will be as under:-

- iii) Answer Key of the question paper will be uploaded on ITBPF recruitment website i.e. https://recruitment.itbpolice.nic.in after the written examination is completed.
- iv) Candidates are not permitted to use electronic gadgets including Mobile Phones, calculators or any other electronic/electrical device. Possession of these items, whether in use or not, will be considered as "use of unfair means" in the examination and appropriate action will be taken against such candidates.

- vi) Candidates found copying or using any unfair means should be disqualified and debarred from further test. An endorsement also be made in all such confiscated answer sheets by the Board/Observer to this effect.
- No representation for revaluation of answer sheet of written examination or re-conduct of written examination will be entertained.

#### MERIT LIST

- (i) After completion of written examination, Merit list in each category, namely UR, SC, ST, OBC (NCL), EWS and Exservicemen will be drawn on the basis of marks obtained by the candidates in the written examination. On the basis of merit, the candidates shall be shortlisted for Verification of original documents and Detailed Medical Examination (DME) as per the category-wise vacancies. The number of candidates examined will be equal to the number of vacancies increased by average failure rate of DME/RME determined on the basis of past experience. However, there shall be no reserve list.
- (ii) SC, ST, OBC (NCL) & EWS candidates who are selected on their own merit without relaxed standards will not be adjusted against the reserved share of vacancies. Such SC, ST, OBC (NCL) & EWS candidates shall be accommodated against the General vacancies as per their position in overall merit list. The reserved vacancies will be filled up separately from amongst eligible SC, ST, OBC (NCL) & EWS candidates which will thus, comprise of SC, ST, OBC (NCL) & EWS candidates who are lower in merit than the last General candidate on merit list of unreserved category but otherwise found suitable for appointment even by relaxed standard.
- (iii) In case of recruitment to the vacancy reserved for Exservicemen and those remained unfilled due to non-availability of eligible or qualified Ex-servicemen candidates, the same shall be filled up from the Non Ex-servicemen candidates as per merit list of respective categories.

#### (iv) Resolution of Tie Cases:

#### PHASE - III

#### VERIFICATION OF ORIGINAL DOCUMENTS

The candidates will be shortlisted in order of merit in each category will be put through verification of original Documents. Original documents will be returned on the spot after verification and self attested copies of certificates will be retained with the application. - (viii) Domicile Certificate issued by Local Revenue Authorities or PAN Card or Aadhar Card or Driving License or Voter Card etc. for verification of citizenship. #### DETAILED MEDICAL EXAMINATION (DME)

- (i) Only those candidates who qualify in the documentation will be required to undergo Detailed Medical Examination (DME) to assess their fitness. The Detailed Medical Examination of the candidates will be conducted in terms of Uniform Guidelines for Recruitment Medical Examination for GOs and NGOs in CAPFs and AR issued vide MHA U.O. 
